## Notes From the Board

The Board is looking at ways we can save, particularly on energy consumption. Based on statements from Hydro Ottawa over the period January 2013 to August 2014, our average electricity consumption was 3647 kWh/day. Highest consumption was 4857 kWh/day in May, 2013 while lowest was 3000 in March-April, 2014.

A representative from Hydro Ottawa toured FP with Heinrich, Chris Bulman and Doug. He pointed out a number of ways we might qualify for incentives under the SaveOnEnergy program. Some possibilities discussed were energy efficient pumps, motion activated electrical switches and LED lighting.

If owners upgraded their appliances to Energy Star models it would help to further lower hydro costs and thus control condo fees. We encourage residents to turn off lights and appliances not in use. According to our monthly financial reports, hydro is the Corporation's largest single expense line and we anticipate increases of 8% per year.

All units have fans installed in their bathroom ceilings. The fans vent air to the outdoor balcony. A properly working exhaust fan supports heat savings in winter as windows can remain closed. For more details see <u>http://frobisherplace.ca</u>

Natural Gas costs are expected to increase at least 20% over the next few years so gas expenditures will be particularly important. Enbridge's engineer, Steve Mogridge, did a site walkthrough at FP with Superintendent Joe and Doug. He has recommended changes we can make to qualify for rebates from Enbridge.

Our windows have helped! During Winter 2010-2011 we had the old windows. By Winter 2013-2014 the new windows had been installed. Our new windows and balcony doors appear to be responsible for a very significant reduction in gas consumption.

### ... and a Question

We have experienced long periods when the swimming pool in the neighbouring building has been inaccessible. At other times some of our residents have complained about poor maintenance and unsanitary conditions. Do we receive sufficient benefit from the \$1500/month fee? The Board would like to get an estimate of how many of us use the pool regularly or occasionally.
